## Developmental Asset #40 - Positive View of Personal Future - March 4, 2015

Young person is optimistic about her or his personal future

- Parent, agency, and community responsibility
- Encourage each young person to find his or her passion in life
  - Youth need exposure to possibilities, both for finding their interests and what living a life with that passion might look like, e.g. occupations, hobbies, research, teaching, etc.
  - Their passions are unrecognized but often visible at a young age (+- 8 years old)
    - Often in what they like to do and what strengths they have
  - o Be open to ANY passion (for example, Steven Spielberg's early years)
- Youth need support for their passions
  - o Enlist neighbors, friends, books, field trips, prominent people in area of passion
- Help youth plan and set goals so they learn they have control about their futures
- Make sure you (everyone reading) spend time with your passion frequently, at least weekly!
- Be positive about your future!
