#### Speech Tournament 2018 Stephanie Facchini

Sixty-four of the top oration students, grades four to eight, from thirteen local public and private schools, competed in the countywide Speech Tournament. The tournament was coordinated by the Nevada County Superintendent of Schools (NCSOS) office and sponsored by Tri Counties Bank, the Rotary Club of Grass Valley and the Nevada Theatre Commission. This year's speech topic was "Technology's Impact: Past, Present, or Future".

The preliminary and semi-finals competition for students in grades four to eight was held on March 8<sup>th</sup> at Calvary Bible Church. The tournament was conducted in a "roundrobin" fashion, with students reciting speeches three times, each time to a different judge. Semi-finalists were determined, and speeches were recited one last time in front of three judges. Three finalists from each grade were selected to proceed to the Speech Finals. The initial judging team consisted of 15 volunteers from local businesses and organizations as well as retired professionals. The

speeches were evaluated on content and delivery with a time limit of no less than two minutes and no more than three and a half minutes.

The student finalists presented their speeches at an evening program on March 13<sup>th</sup>, held at the Nevada Theatre. The esteemed panel of judges consisted of representatives from local Toastmasters groups. Each finalist received a first, second, or third place trophy and a \$25 Book Seller gift certificate. These awards were presented by Kathleen Kiefer, Director of Curriculum, Instruction, and Accountability for NCSOS; Judy Wirkner, Vice President, Branch Manager of Tri Counties Bank; and Robert Long, Past President of the Rotary Club of Grass Valley. Research shows that exposure to violence and trauma can seriously undermine a child's ability to learn, form relationships and focus appropriately in the classroom. To support students in Nevada County, a united effort among local agencies has led to the adoption and implementation of the Handle with Care program. Nevada County Handle with Care is modeled after the West Virginia Handle with Care and the Stanislaus County FOCUS program. The program launched February 6, 2018.

This new initiative enhances communication and collaboration between first responders (law enforcement, fire fighters, emergency medical responders, etc.), and schools. A "Handle with Care Notification" alerts the school that a child may have been exposed to a traumatic incident (i.e. domestic violence, child abuse, death in the family, witness to a crime, loss of home due to a house fire, etc.). No specific details about the incident are given, just one simple request: To focus on the child and handle them with care. Confidentiality is maintained at all levels.

How it works: When a child is exposed to violence or trauma, a first responder will send the designated official for the child's school a "Handle with Care" notification; no details of the incident are provided.

School staff members, while observing the student throughout the day, will aim to be especially sensitive to student needs. Provisions for a quiet place to rest, assistance with meeting basic needs, homework/test forgiveness or delay, a visit to the school nurse or counselor, or referral to an outside agency will be provided as needed.

The Nevada County Superintendent of Schools Office is grateful for the collaborative efforts of many local agencies to provide a safe and productive learning environment for our students as we seek to "handle every child with care".

# McKinney-Vento: Meeting the Needs of the Homeless

In 2016-17, 341 Nevada County children and youth were identified as homeless under the McKinney-Vento Act, a 22% increase from the year prior. Students may be considered "homeless" if they lack a regular, fixed, and adequate nighttime residence (including families doubled-up due to economic hardship, children who are unaccompanied/not living with a biological parent or legal guardian). Children and youth who qualify under McKinney-Vento are immediately eligible for free & reduced lunch as well as additional supports and

connections to services (e.g., needed school supplies, school fees, weather appropriate clothing, tutoring). Each school district has a designated McKinney-Vento liaison whose function is to assist with connection to needed services. If you know of a child who may qualify, contact your district liaison.

# Step Up to Kindergarten! and Step Up to Pre-School!!

As the Step Up to Kindergarten summer school-readiness program enters its seventh year, it is becoming a joint venture of NCSOS and First 5.

For three weeks in July, entering kindergarten students will get comfortable in a kindergarten classroom, learn routines, and focus on social-emotional and executive function school readiness skills in a small class setting at 5 schools around the county (Bell Hill, Union Hill, Scotten, Alta Sierra, and Cottage Hill). Children entering kindergarten at any school in the county are welcome to apply for a slot.

And launching this year is the Step Up to Preschool program, for children turning three by September 1 up through those entering Transitional Kindergarten in the Fall. Preschoolers will enjoy half days in small classrooms at Our Kids' Place and the Sierra College Child Development Center in Grass Valley, at Alta Sierra School, and at Cottage Hill from Wednesday, July 11 through Tuesday, July 31. The three-week school readiness program runs from 9:00 a.m. to noon each day.

This program joins the long-term success of Step Up to Kindergarten. If you know of a child going into preschool or kindergarten anywhere in the county, you can refer them to this terrific, free program. Staffed by high-quality, experienced teachers, these programs are a great way to help children be ready for school.

#### **Trauma-Informed Care**

This training is intended for family strengthening professionals that work with children and families who may have experienced trauma. By the end of the full-day training, participants will be able to define the types of trauma, describe the impact of trauma on the development and well-being of children, adults, and family support staff, and more. #### **Brief Intervention**

Thursday, May 10 from 9:00 a.m. -3:30 p.m. the NCSOS office is hosting a free training on Brief Intervention (BI) Training. Registration is required and space is limited. Go to www.eventbrite.com to register. The Target audience is Tobacco Use Prevention Education (TUPE) site coordinators, school administrators, educators, staff, counselors and nurses. BI is a short-term counseling intervention that consists of 2 to 4 sessions aimed at adolescents who use alcohol and/or other drugs. This approach uses motivational cognitive behavior interviewing, therapy and the stages of change model to meet the needs of adolescents. Space is limited. Lunch included. Six hours of continuing education credits are available for BRN and counselors for a \$25 fee. # **SMART: Meeting the Needs of Students & Families in Crisis**

If you are concerned about the welfare of a child, have had limited success family engagement provision of services and are unsure about the involvement of other agencies, SMART (Special Multi-Agency Resource Team) convenes to address the needs of families in crisis within Nevada County. By working collaboratively with parents schools to identify strengths and concerns, the Team is able to effectively link families to appropriate, local services and remove any barriers to such services. The goal of SMART is to keep children safe, healthy, in-home, at-school, and out-of-trouble. The team consists of representatives from Child Protective Services, CALWorks, Public Health, Juvenile Probation, Behavioral Health, Victor Community Support Services, EMQ Families First, Sierra Forever Families and the schools (additional agencies included for case specific issues- Alta Regional Services, Foothill Healthy Babies, etc.).
